1. Call to order:

Councilor Cooper Brought up that Gresham set up an internet safe exchange zone and asked that PSAC think about recommending the same for Fairview to the City Council. Chief Smith will do some research on where camera placement may be and get back to the group at the next meeting.

Chair Marker is worried about all the sharp edges that are left on the trimmings. He is bringing it up because it is a safety concern. Council Liaison Forsythe asked if there were any ordinances to get this cleaned up.

Vice Chair Williams said that in his HOA they have a residence that throws garbage around the neighborhood and threatens Council Members. The HOA members did turn him in to the police department. But they got the feeling that they were just "blown off".

Chair Marker said he discussed with Alan Berry about storing supplies for disaster preparedness when the public works building is rebuilt.

5. Old Business:

There was much discussion among members about emergency preparedness.

Chair Marker asked if there was anyone interested in joining Chief Smith to attend The Emergency Management meeting for Cities and Unincorporated areas across Multnomah County. He is still waiting on the date to be set, possibly May 2nd. Vice Chair Williams volunteered to attend with Chief Smith.

Chief Smith met with Alice Busch. She is working on the curriculum for the seminar. Alice is also working on updating some maps for the neighborhoods.

Chief Smith discussed the upcoming Easter Egg Hunt and asked the group if they wanted to be at the event and other events to educate citizens about PSAC and to promote disaster preparedness.


6. Adjournment:

Chair Marker motioned for adjournment. Member Woods seconded. The motion was passed unanimously. The meeting was adjourned at 7:10 PM.


